## Training Day Schedule

The starting time for Sunday March 16th will be at 8:00 am and we will go until about 12:00 or so. As we did last month, we will have different stations going on at the same time doing different things but will cover things from a-z. We will be concentrating on a specified task at each training day and having everybody in the group show that their dog can do this.

### **March 16th Sunday at 8:00 AM**

**“Whoa” training and force breaking to retrieve. This will be table training work. We will show you how to do these tasks. It takes four (4) weeks to train this into your dog and that’s working it every day for 10 minutes.** *(Editor’s Note: don’t listen to me and Sam—she and/or I took about eight months before we had it down, and that’s with twice a day for most of those weeks and months. That’s why you want to have Bob show you how to do this right.)*

### **April 20th Sunday at 8:00 AM**

Dogs that are ready to retrieve get two more pigeons in the field to point. They should be at least steady to flush. Preferably they should be steady to shot and the retrieve should be polished. Your dog should come straight in and present the bird without hard-mouthing.

### **May 18th Sunday at 8:00 AM**

Tracking and drags. Your dog will learn to track a live pheasant and then do a 100-yard retrieve of the drag.

### **June 22nd Sunday at 8:00 (June 15th is Father’s Day so we changed the schedule to the 22nd!)**

The tasks will involve the duck on the water and blind retrieves.

***The rest of the year’s schedule will be announced later.***

### SALE OF PRADO

Ron Gibbons of Quail Unlimited has informed us that Janet and Don Richardson have transferred the management of the Prado Dog Training Facility to Reuben and Elena Llamas effective February 11, of this year. Reuben plans to farm more of the land and still have fields available with appropriate cover for dog trials and training. For the time being at least, the prices will remain the same. ### CANINE EUGENICS, AGAIN

The Los Angeles City Council has enacted legislation requiring the mandatory sterilization of all dogs and cats (I'm sure they are really going to get after those pesky cats!) over 4 months of age. Effective June 3rd, the ordinance mandates a significant fine for violation. In addition to being neutered, dogs will have to be implanted with an identifying microchip. Not surprisingly, the price of annual dog licenses will go up from \$15 to \$20 for sterilized dogs and \$60 for unaltered animals. The legislation is similar to AB 1634, the state-wide canine eugenics legislation promoted by PETA that was introduced last year and withdrawn after vigorous opposition from many organizations including the AKC. AB 1634 will be re-introduced this year with its sponsors hoping opponents will have forgotten about it or will have trouble mobilizing opposition again.

The spay/neuter requirement applies to all dogs except those **(1)** registered with an registry approved by the LA Animal Services Department *and* that have competed in at least one dog show or one "sporting dog competition" (a term to be defined in regulations yet to be adopted) in the last year, or is being trained to show or compete (?) or **(2)** has earned (or if under three years of age, is earning) an agility, herding, protection, hunting or other title from an approved registry, or **(3)** that work with law enforcement or the military, or **(4)** assisting the disabled **(5)** that a licensed vet certifies should be neutered later or is unsafe to be neutered because of its health or **(6)** owned by someone who has a valid breeding permit from the City. Supporters wanted to prohibit all dogs from being born until all animal shelters are emptied.

The City asserts that the ordinance would be enforced when a dog is picked up by the dog catcher for having attacked another animal or a person, or for barking or for having been neglected by its owner. I suspect that the principal way compliance will occur is when the owner seeks to renew the dog's license.

All this seems a bit like curing juvenile delinquency by sterilizing all women (or men?) who might be of child bearing age. Now all we have to do is wait for the State to mandate this for all of our dogs.
